Advisory

In line with ongoing review of entry facilitation requirements, the following visa regulations for Taiwan passport holders have been revised as follows:

1. Taiwan passport holders may enter the Philippines for tourism purposes without a visa for a non-extendible and non-convertible period of fourteen (14) days upon presenting the following requirements: a passport valid for at least six (6) months beyond the contemplated period of stay, confirmed hotel accommodation/booking, proof of financial capacity, and a return or onward ticket to the next country of destination.
2. For Taiwan passport holders intending to visit the Philippines for more than fourteen (14) days **or for purposes other than tourism**, visa shall be required, with the following basic requirements:
 - a. Duly Accomplished and Signed Visa Application Form;
 - b. Passport valid for at least six (6) months beyond the intended period of stay in the Philippines – Original and Photocopy of bio-data page;
 - c. Taiwan I.D. – Front and Back Photocopy;
 - d. Proof of Round-Trip Ticket Reservation, if any;
 - e. Visa Application Fee.

Other documents may be required on a case-by-case basis.

3. For other visa categories such as applications for multiple-entry visa, crew-list visa, and long-term visa, the standard requirements and procedures shall remain applicable.

These adjustments will take effect from 01 July 2025

因應入境菲律賓的相關規定調整，現針對持臺灣護照人士之簽證規定修訂如下：

一、自 2025 年 7 月 1 日起，持臺灣護照人士如以觀光為目的入境菲律賓，可免簽證停留 14 天。期滿不得延期且不得改換其他簽證類別，入境時須備妥下列資料：

1. 所持護照效期應在 6 個月以上（自預定由菲律賓離境日起算）
2. 已確認的飯店住宿或訂房紀錄
3. 足以負擔在菲律賓停留期間之財力證明
4. 回程機票或前往第三國的機票

二、持臺灣護照人士如欲停留超過 14 日或非以觀光為目的入境菲律賓者，須事先申請簽證，並備妥以下基本文件：

1. 正確填寫並簽名的簽證申請表；
2. 護照正本及影本（所持護照效期應在 6 個月以上；自預定由菲律賓離境日起算）
3. 身分證正反面影本
4. 來回機票訂位證明（如有）
5. 簽證申請費用

※視個案情況，可能需補充其他文件

三、至於其他類別之簽證申請（如多次入境簽證、船員名冊簽證及長期簽證等），仍依既有規定及程序辦理。
